#### I. Welcome and Call to Order

Lori Genaw called the meeting to order and welcomed everyone to the annual meeting at Greaters Ice Cream.

#### II. Reports

a. Secretary (Gayle Ingram)

Curt Givens moved to accept the minutes of the August 8, 2011 board meeting. It was seconded by Rick Roberts and passed unanimously.

b. <u>Treasurer</u> (Tami Woodrow)

Curt Givens moved to accept treasurer's report. It was seconded by Jennifer Scott and passed unanimously.

## c. Membership (Amy Runyon, chair)

Amy reported that she has received two new applications. No one has responded to emails she sent to applicants who have submitted applications but have not been voted on at a membership meeting. Several board members stated that they have left applications in her mailbox at the building.

#### d. Registrar (Carole Lenehan)

Carole reported that Session Four had a total of 104 dogs registered; 75 of those are in obedience classes. It was noted that the member application needs to be updated related to applicants and additional members. Only the member applicant can receive half price classes.

Carole received a request from ASCA to hold a night trial at the Land. Board members agreed that they could hold the event as long as they were finished by 9:30 and everyone was off the property and lights were out by 10:00 p.m.

### e. Obedience (Elaine Stoermer, Director)

Elaine reported that the obedience classes are going well. She is hearing positive remarks about the puppy class that was moved to the basement. She is looking at options related to a request she has received to rearrange some of the obedience class schedules to accommodate a change in nights for the Freestyle class. They

are looking into the possibility of renting A/C units for the back room for use during the September 24-25 Obedience/Rally Trial.

## f. Agility (Maggie Melton)

Maggie reported that entries are now being accepted for the October 8-9, 2011 AKC trial at the Champions Center in Springfield. She's already received registration for 131 runs. The February trial has also been booked at the Champions Center. The club has purchased one computer and has asked for donations of flat screen tvs to connect. Trial software has been ordered. There will be two agility equipment auctions: 1 outside in the near future and 1 inside at a later date.

# g. Conformation (Jennifer Scott)

Trish Clute's class is already 2/3 full for Session 5 which begins the end of September. The October confirmation show is moving forward and the premium will be online shortly. Tami will purchase Breed Standards software for their use. Jennifer is looking for another seminar to offer to club members. She has written an article for the next Crateliner.

# h. Earth Dog (Curt Givens)

The November tests are set. As in the past, they will be frying turkeys on Saturday night. Information will be posted prior to the test so people can rsvp for dinner. They are looking for a judge for June which will be a four day test. Curt reported that he has been finding poop bags stuffed in the earthdog dens at the Land again. He can't tell if this is being done during classes or if people are doing it when they exercise their dogs at other times.

# i. Operations (Rick Roberts)

It was reported that the A/C was working well at the Obedience trial this past weekend. Rick reported that the Land will be moved right before the September 11<sup>th</sup> Responsible Dog Ownership Day (RDOD) event.

# j. <u>Sunshine</u> (Cheri Davis)

Cheri reported that flowers were being sent to Cindy Alles.

# k. Publicity/Public Relations (Cheri Davis)

Cheri reported that there was nothing new to report since the last meeting. She inquired whether the club has sponsored Waco Wag-In Dogfest in the past. This event is being held on September 10<sup>th</sup>, the day before the RDOD. GCDOC members will be doing freestyle and K-9 performances and Becky Brown will have flyers at her booth. Cheri plans to solicit more members to participate in club promotion events at the September Membership meeting.

# I. Store (Roberta Rupert)

Roberta reported that she received a request to order Martingale dog collars without chains for sale in the store. The club currently has 500 treat aprons.

# III. Continuing Business

AKC "Responsible Dog Ownership Day – Sunday, September 11. Lori Genew and
Cheri Davis presented an update on plans for the RDOD. Board members were asked
to distribute flyers to local pet stores, veterinarian offices, and other pet friendly
businesses. Maggie has been talking to all the agility classes and inviting students to
attend. Announcements have been posted on Facebook and on the Yahoo Group.

Mike Kasik has been asked to post information on the GCDOC website. Lori reviewed the layout for activities at the property and Cheri reviewed the list of vendors that have confirmed attendance. Lori has been contacting members to be part of the Meet the Breeds area. Members are asked to have a write up on their breed available to share. More GCDOC business cards and brochures need to be ordered. Maggie will arrange for an extra porta potty. We also need to have a veterinarian on site during the event. We also need to find an AKC Breed Poster.

# Membership Meeting (Sept. 19)

The next Membership Meeting is scheduled for Monday, September 19<sup>th</sup> at 7:00 p.m. Members will be asked to bring a snack to share. Several items were identified to be discussed at the meeting:

- Ask for volunteers to distribute GCDOC materials at dog events throughout the vear.
- Explain that members need to notify the trial chairs when they plan to work during a trial. Members are showing up at events and expect to work. Sometimes this is good, but often the worker schedule is already filled. Members who are trying to get their required volunteer hours at the end of the year have become angry when they don't get to work the number of hours they hoped for.
- Remind members that if they use the Land, they must pick up after their dogs. We are finding poop bags in the Earthdog dens. This is not acceptable. There are trash cans where bags can be deposited.
- Remind members that when dogs have accidents in the building, the poop bags should be taken outside...not placed in trash containers inside the building.

Information for club members only should not be posted there.
