Correct BHA registration number IS required. Entries may be refused for cause at the discretion of the event committee.

Ribbons will be given to all qualifiers in all classes. Placement ribbons will be awarded for 1st through 4th in each class except Instinct. Special awards will be given for each High in (regular) Class and for any dog earning a RATCH or RATCHX. **Please notify Chairman or Secretary if you will be eligible for RATCH or RATCHX.**

To those of you staying in area motels:

Most Barn Hunt competitors are model guests, but it is becoming increasingly difficult to find motels that will accept pets due to bad experiences with excessive barking dogs. Please make it possible to have trials in the future. Never leave your dog(s) unattended in a motel room and please clean up after them. Your entries in future trials may be affected by failure to abide by these rules.

Running Order:

Dogs will be run in height order from Small to Large on Saturday Trial 1 and Trial 2 and from Large to Small on Sunday. The order may have to be adjusted to accommodate handlers with multiple dogs in the same class. Dogs being handled by the same person will be separated into differently staged groups.

Measured Height Divisions (owners are responsible for correct height on entry):

Small dog – 13" and under at withers Medium dog – 13.1" to 18" at withers Large dogs – over 18" at withers

Class divisions will run:

Saturday: Instinct 1 (Trial 1 only), Novice 1, Novice 2, Open 1, Open 2, Senior 1, Senior 2, Master 1, and Master 2. Sunday: Instinct, Novice, Open, Crazy 8s, Senior, Master. Definitive schedule and class entry #s will be provided in final confirmation letter.

Master Blind will be 3 dogs per blind.

EXHIBITOR INFORMATION

- Registration information and current BHA rule book can be found at www.Barn Hunt.com. Dogs are required to have a registration number prior to entry. Allow 2 days to receive your number. Exhibitors are responsible for knowledge of the rules. A copy of the rules will be available at the Secretary's table.
- Flooring in the trial area is rubber mats. "Accidents" in the building must be reported to a committee member and cleaned up immediately. A \$5.00 fee will be charged for accidents in the ring. Cleanup materials are available.
- Flexileads, prong collars, bark collars, electronic collars of any sort, or head halters are NOT
 PERMITTED on trial grounds. All dogs must be on lead and under control while on the trial
 grounds except when running the course. Approved collars include flat snap or buckle of solid
 construction and leather or nylon leads. Limited slip martingale and single piece slip collar/leads
 and harnesses with the exception of head-halter type are allowed. Dogs MUST run "naked" i.e.
 without a collar or harness that can be easily and quickly removed and replaced.
- Bitches In Season are eligible for entry but will be required to be kept separate from all other
 dogs and will be run at the end of their class. A separate "potty" area will be available. If bringing
 a bitch in season, please notify the trial secretary and inform all exhibitors at the judge's briefing.
 BIS will be required to compete in pants/britches.
- Move ups: Same day move ups from Trial 1 to Trial 2 or day to day Saturday Trial 2 to Sunday
 Trial 1 will be allowed. Move up forms will be available at the Secretary's table and must be
 completed at least 15 minutes before the move-up trial. Move ups due to titling at a previous
 trial must be received no later than 6:00 pm on Thursday, May 18, 2017 by mail or e-mail only.
- Lunch will be available. There are also several fast food restaurants north on Brandt to Harshman including Wendy's, Burger King and Sonic.

- A waiting list will be maintained. Please notify the Secretary by e-mail as soon as possible if you are canceling.
- Refunds are available until the closing date of the trial if you wish to withdraw. After the trial closes, entry fees will not be refunded unless there is an available entry on the waiting list. Refunds are available for injured or deceased dogs. Notifications of injury or illness must be made to the trial chairman or trial secretary within 30 minutes of the start of the trial. A veterinarian note is required to be provided to the trial secretary within one week of the trials. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused or barred from competition by action of the Event Committee.
- Exhibitors are solely responsible for entering the staging area/blind when asked and must remain in the staging area until called to the gate when it is their turn to run. The judge is not required to wait for any dog holding up a class. Only **ONE** person per dog allowed in the blind.
- Treats or quiet (non-noisy) toys are permitted in the staging area/blind but must be left behind
 when called to the gate. NO toys or treats are to be carried into the ring. A basket for the items
 will be available. NO cell phones or other communication devices in the blind area.
- Please observe marked potty areas. Potty bags and disposal buckets are available next to the fence. The grass near the street or next to our neighbors is not to be used.



DIRECTIONS TO 542 Valleycrest St, Dayton, OH

From the North or West, take I-75 south to Stanley Ave. Turn East to Brandt Pike (OH Route 201) Turn north (left) onto Brandt and proceed to Valleycrest on the right **immediately** north of Dayton Trailer Sales.

From the South, take I-75 North to OH-4, follow OH-4 to the Stanley/Findlay St. exit, Turn left on Stanley to Brandt and follow the above directions.

From the East, take I-70 west to OH-4 and exit south. Exit OH-4 at Stanley Ave. and follow above directions, OR exit OH-4 at Harshman and go west to Brandt. Turn left onto Brandt and go to just before the trailer sales. (This will be after North Dayton Garden Center)

Information about Gem City's site:

Our land facility offers 10 acres. Barn Hunt is located in the Faulkner Building (first building on left at entrance of gate). Porta-Johns are available. No indoor crating but there are plenty of trees to park under and crate in your cars or set up a portable canopy for shade. Please consider bringing your own chair.

Camping will be permitted on the grounds. Fee is \$10.00 per night. No hook-ups are available. Anyone dumping on the grounds will be asked to leave. No refund will be given.

Crazy 8s info:

Complete rules and description are available in the Barn Hunt Rules. What follows is a short description of the class.

Crazy 8s is a non-regular, titling class open to **all** dogs regardless of level. A title of any kind is **not** required. It is a good practice for lesser experienced dogs to find multiple rats.

The time is 2 minutes and the class in not divided by size. There are a total of 8 rats and 4 litter tubes on a senior/master course along with a 2-5 turn tunnel. The team earns 10 points for each rat found, 10 points each for the tunnel and climb (only once each) for a total of 100 points. Also available is an additional 5 points for a team that finds all 8 rats in 1:45 minutes and a second 5 points for a team that finds all rats in 1:30 minutes.

Teams must find at least one rat. There is a 20 point penalty for no tunnel or climb and must have an accumulative total greater than 0 to receive a qualifying score.
