Attention Exhibitors

- The show site will be available to exhibitors at 7:30 a.m. each morning. Consult Judging Program for time of judging. Dogs need to be present only for scheduled judging and will be released if not needed for further judging.
- Transfers will be allowed for this trial unless the class is already filled. All transfers will run at the end of their class. Please help the trial secretary by submitting your transfer by Sept.22, 2017. Transfers must be submitted using the transfer form, which can be found on the AKC website (akc.org). Transfers will not be accepted after 7:30 a.m. on the day of the trial.
- Judging procedure may be modified to accommodate disabled handlers.
- All dogs must be kept on leash or crated at all times, except as allowed in the show ring.
- Please exercise your dog in the designated areas. Please clean up after your dog.
- Crates may be left inside the show facility overnight in designated areas; dog may not be left overnight. Pens must not block entrance or exit of doorways or use prime parking areas.
- NO ENTRY CAN BE ACCEPTED WITHOUT FEES, SIGNATURES OR THE “AGREEMENT” ON THE REVERSE SIDE OF THE OFFICIAL AKC ENTRY FORM. UNSIGNED CHECKS AND RETURNED CHECKS DO NOT CONSTITUTE PAYMENT OF FEES. NO ENTRY SHALL BE MADE AND NO ENTRY SHALL BE ACCEPTED WHICH SPECIFIES ANY CONDITION AS TO ITS ACCEPTANCE.**
- Changes, additions or corrections to entry forms must be received in writing, e-mail or by telegram prior to the close of entries. Those received by telephone are not acceptable. Gem City will not be responsible for errors made on entries. Please double check entry prior to sending. Owners are responsible for errors. No entry fee will be refunded in the event of such errors or cancellation of entries after the published closing date.
- Acknowledgement of entries will be made as soon as practicable after entries close. An identification notice for each dog and Judging Program will be mailed to all exhibitors.
- Entry fees for all regular classes included AKC fees of \$3.50 for a dog’s first entry in a given trial and \$3.00 for subsequent entries of the same dog in the same trial. Obedience and Rally trials are different trials as are the trials on separate days.
- Entries fees will not be refunded in the event that a dog is absent, disqualified, excused by veterinarian or judge, or barred from competition by action of the Trial Committee. No entry fee will be refunded if the show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency, act of public enemy, strikes, or any other cause beyond the control of Gem City Agility Club.
- Refunds for females in season (after closing date) will be given upon satisfactory verification of bitch being in season less \$5.00 processing fee; satisfactory evidence may include vet’s statement; notice to be given per AKC rules Chapter 1, Section 14.
- Gem City assumes no responsibility for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs or property and further assumes no responsibility for injury to children.
- Dogs must be ready for judging. Neither the club nor its Trial Secretary will be responsible or obligated to furnish any service for notifying exhibitors or their agents of class judging. Judges need not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the judging rings.
- The club reserves the right to substitute a prize of equal or greater value. All awards must be claimed the day of the show – None will be mailed. Unclaimed prizes become the property of Gem City Agility Club.
- Food, snacks and beverages will be available at the show site for purchase. There are fast-food/restaurants near the show site.
- No smoking is allowed in the building. No alcoholic beverages are allowed on show grounds or in parking areas.**
