Registrar's Report

Conformation Report

Trish Clute reported that she is planning to hold a puppy match next year, perhaps in March, although the exact date has yet to be determined.

Obedience Report

Kathy Combs reported on a smooth start-up of Session V classes. A new manual has been distributed to beginner's class instructors. Pilot classes using the new manual during Session IV went well. Therefore, they will use the new manual going forward.

Agility Report

Marra Wollpert reported that AKC agility trial for October 8th, 9th and 10th did not fill. Approximately 80% of the capacity for runs has been filled. Marra mentioned that she needs workers desperately.

Marra reported that the USDAA trial was very successful. There were very favorable compliments from participants, no complaints and high participation.

Roger noted that the building's fire extinguishers were last serviced in 1991 according to the tags. He will look into getting the extinguishers recharged or serviced.

Roger reported that additional stone has been added to the driveway at the land.

Public Relations

Morene Stickrod reported that the Responsible Dog Ownership Day event was successful. An estimated 500 people attended. Carole Lenehan, event coordinator, suggested that we continue hosting and managing this event in 2005. However, we will need to appoint a new chairperson for next year since Carole does not want to continue in that capacity.

Earth Dog Report

Curt Givens reported that AWTA test entries are still coming in.

Curt reported that the AKC approved the judge's panel for the November test. The premium will be posted to the club website next week.

Special Programs Report

Curt Givens reported that the Rally classes are full. The four week program planned around meeting conflicts has worked out better than the eight week program.

Roger George reported that progress is on hold pending the assembly of the club's financial documents and the community benefits documents.

Building Committee Update

IV. New Business Topics

Agility Equipment Available for Use at the Building

Trish Clute noted that there is very little agility equipment in the building right now. Marra Wollpert stated that it was necessary to move extra equipment out to the land for the USDAA event and AKC trial. The equipment will be moved back to the building after the October AKC trial. Furthermore, it was noted that some jumps were loaned to the Humane Society for a weekend.

Requirements for Dog Vaccination

It was reported that Jeannette Burger has been asking for vaccination records to accompany agility class registrations. Historically, this has not been a club practice. Curt Givens motioned that handlers of new dogs entered into class will need to show shot records prior to the first class at GCDOC. Marra Wollpert seconded the motion which passed on a majority vote. The announcement of this new requirement should be made in the *Crateliner* and at the Annual Meeting along with a reminder that bitches in season are not permitted at any GCDOC facility excepting club sanctioned puppy matches.

Eagle Scout Project Proposal

Curt Givens reported that the club has been approached by a Boy Scout seeking a community service project to complete Eagle Scout requirements. The project will be to clear a path at the land along the edge of the fence lines. Curt made a motion to have the club accept such a service project should it be offered. Trish Clute seconded and the motion passed on a majority vote.

2005 Budgets

Christopher Beckerdite led a budgeting session for all areas. The output was an initial draft of a 2005 operational budget for revenues, expenses and operating income.
