**Call to Order**: Meeting was called to order at 7:10 p.m. by Chris Kiefer. Motion to approve board minutes from meeting held on 5/19/19 with changes was made by Cathy Wright; seconded by Cindy Wilkins. **Conformation**—Cathy Wright. Classes will resume next session. A discussion was held on the possibility of running two classes if enough participants were interested. An instructor would be needed for the additional class.

Lure Coursing—Leah Schiller. Next trial is September 28. The Fast CAT trial held on June 22 and 23 at K9 Splash Zone made a profit of \$3,445. The secretary received two checks for entries which bounced. Over \$2000 was paid to rent and use the K-9 Splash Zone facility. A discussion was held on the possibility of buying lure operating equipment and hosting the event at the GCDOC land versus renting.

**Obedience** — Pam Murn. Two instructors will not be teaching this session. Ashley Huehn will not be teaching the WCRL Rally courses and Bill Alles has to have knee replacement surgery and will be unable to teach the Advanced Beginners course.
