Board Members Present: Angela Profitt, Diana Stromley, Tami Woodrow, Kathy Roberts, Sherri Heizer, Donna Jennings, Maggie Melton, Alicia Heidorn, Barb Siler, John Clifford, Ashley Huehn.

Call to Order: Meeting was called to order at 7:35 by Angela Profitt. Motion to accept meeting minutes from 12/1/21 was made by Diana Stromley, seconded by Sheri Heizer. Motion passed unanimously.

Vice President: Diana Stromley. Nothing to report.

Membership: Tami Woodrow. Diana Echols was dropped from membership in 2019. She has applied for reinstatement. Tami Woodrow motioned she be reinstated for membership, Maggie Melton seconded. The motion to reinstate Diana Echols was passed unanimously. Membership is down to approximately 175 members. Tami has some applicants who applied over a year ago and have not completed the volunteer hours. Tami is going to email these applicants to see if they want to continue with the application. Barb Siler proposed going to the beginner classes to promote club membership. She will put together a sheet listing the advantages of club membership to be handed out to students on the final night of class. Barb is going to put together a spreadsheet with a list of classes so board members can volunteer to do this.

Tami Woodrow proposed changing the standing rules to state there are two different vouchers. There are currently three different vouchers: instructor voucher, service voucher, and the blue-ribbon vouchers. The blue-ribbon vouchers and the instructor vouchers have the same benefits and are redundant. The instructor vouchers will be eliminated and no longer given out after the current supply runs out. Tami Woodrow and John Clifford will make the necessary changes to the standing rules.

Treasurer: Kathy Roberts. The Club has approximately 126,000 cash on hand. The club did better financially in 2021 when compared to 2020. There was an increase of approximately 56,000 this year. Motion to accept the treasurer's report was made by Ashley Huehn, seconded by Diana Stromley.

Registrar: Maggie Melton. This session there are 95 students registered for obedience classes. 68 are in the lower classes and 27 are registered for the advanced classed. There are 80 students registered for 14 different agility classes. Instructors need to push students to go into the advanced classes. Maggie asked Chris for a waitlist button on the registrar page. When a class is full it disappears from the page. She would like the page to say the class is full with the ability to add students to a waitlist. Chris is going to work on this.

Conformation: No director

Obedience: Kristina Morgan. Absent. Obedience Report: Work has started on next session schedule. She will get with Sherri about using the turf room on Monday nights for rally.

Agility: Sherri Heizer. Classes full. The sheltie trial in December was a success.

Outdoor improvements

It was discussed that crowding going into the building could be fixed if the back entrance was improved. This would involve upgrading the drain system, building a path with lights, and replacing the doors. Better lights are also needed on the side of the building, possibly with motions sensors. This will go to the building committee who will need to secure quotes on the needed work.

Barb Siler would like to put together a list of dog behaviorists in the area as a reference for students who may need this help. It was discussed that such a list had existed at one time. Barb will investigate this, put a list together and run off copies. The copies will be placed in the drawer for instructors to hand out to students as needed.
