Currently we need to clean it for the agility trial June 2-4; obedience trial June 10-11 and possibly before June 24 when there is a 4H rental. She will get with Kristina about the 4H rental.

She has put together a file that shows how to set up the turf room with words and pictures. This will be for renters to refer to so that they know what to do prior to and after a trial. This will be placed in a binder and put in a location for renters to have access.

She is starting to look at how to schedule classes for the growing numbers we have in classes.

The city of Dayton has been cleaning up the Valley Crest superfund toxic landfill for many years now. Now that the clean up is almost complete the residents would like this road from Brandt to remain open. The City of Dayton is in negotiations with the owners. In order to complete the project, the city of Dayton needs 1550 sq ft. of land from Gem City. The city would like Gem City to donate this land. Pam stated that is would be on the other side of the fence and would not impact members in any way. The club would not incur any cost. Pam would like to write up a resolution to donate the land in question. The resolution must be signed by all board members. Kathy Roberts suggested that this resolution be presented at the next membership meeting.
