The Barn Hunt Grounds will be marked separate from the UpDog Grounds. Crating area (outdoor/vehicle) will be on Barn Hunt grounds with crating permission granted for UpDog attendees. Crating areas are subject to Barn Hunt rules. Barn Hunt rules for Bitches in Season will apply. See the Barn Hunt Competitor rules at [Barnhunt.com](http://Barnhunt.com) for complete rules.

Permission has been granted by the Barn Hunt Association, LLC, for the holding of this barn hunt trial under BHA Rules & Regulations.

Judge of Record and Event Official dogs may be judged before the official start time or as the first blind(s) of the event. Judges are limited to 8 hours of judging and a maximum run value, which will require this club to limit entries.

**JUDGE:** Lynsey Fuegner, BHAJ-235A, Maryville, IL will judge all classes. Judge Rachel Corbett, BHAJ-286A will Relief/Back-Up Judge.

**DAILY RUNNING ORDER:** Two consecutive runs daily offering these classes: Instinct (Only one per day), Novice, Open, Crazy 8s, Senior, Master. The club reserves the right to change the run order based on entries received and shall send the judging schedule before the start of the Trials via email.

**MOVE UPS:** Not all level move-ups or move-downs may be possible. Contact the trial Secretary as soon as possible.

**ENTRY FEES:** Instinct, \$10; Novice, Open, \$20; Senior, Crazy 8s & Master \$25. Late entries are not guaranteed entry and will be accepted only up to judging limits. Confirmations will not be sent for late entries.

**ATTENDEES ALLOWED:** Open to all breeds 6 months or older. Dogs must have a registration number with Barn Hunt Association.

**TRIAL CONDITIONS:** Trials will be run indoors, climate-controlled, concrete floor with rubber matting. No indoor crating.

**BLINDS:** Covered, outdoor blind, 10'x20' or larger, and dog separators will be utilized. No more than 5 or 6 dogs per blind.

**ACCESSIBILITY:** The facility and grounds are handicapped accessible.

**ENTRIES:** Open on June 10, 2024 at 8am. Early entries will be discarded. We will continue to accept entries until limits are met or until the closing date of July, 31 2024 at 12pm. Late entries (if limits are not met) are accepted at no additional charge and will be taken from the closing date until August 7, 2024, 12pm. If the trial fills, a waitlist will be maintained.

**CRATING:** Dogs will be crated in vehicles or outdoors and must be always on leash when not actively hunting.

**GROUND:** The trial building is set on several acres. The land is completely fenced except for the front gate. Portable restrooms and running water are available.

**ACCEPTED METHODS OF ENTRY/PAYMENT:** You may enter by filling out and sending this form or the printed form on the Barn Hunt website, with a check payment to the Trial Secretary. **If you use the form on the Barn Hunt website, you must print the form and send it in with a check.** You may also enter and pay electronically.

**ELECTRONIC ENTRIES AND PAYMENT:** We are taking and encouraging electronic entries and payments for this event. A 3.5%+.49 processing fee will be added to electronic entries. To enter and pay electronically use the link:

#### **SCHEDULE FOR SATURDAY and SUNDAY**

7:30am - Grounds open, Check-In

8:15am – General Briefing, Instinct Briefing

8:30am - First Instinct blind loaded. Run order I1, N1, N2, O1, O2, CZ8s 1, CZ8s 2, S1, S2, M1, M2 (run order subject to change) Grounds Close 30 minutes after the last dog runs.

**COLLARS & LEADS:** No electronic collars, bark collars, muzzles, or head halters allowed on Barn Hunt show grounds. Per Barn Hunt Association all pinch collars must be covered.

**BITCHES IN SEASON (BIS):** May compete but must be run at the end of each class. BIS must always wear pants when not in their vehicle except when being pottied in the designated BIS potty area. Please inform the Trial Secretary before the start of the trial so your fellow exhibitors can be made aware of BIS present.

**HEIGHT DIVISIONS:** Small – Dogs 15” and under at the withers, Medium – Dogs 15.1” to 22” at withers, and Large – Dogs over 22” at withers.

**DOG AGGRESSION:** A judge or the trial committee may dismiss any dog behaving in a threatening or aggressive manner toward another dog or person. Please report any issues immediately!

**ANIMAL SAFETY:** The safety of our dogs and rats is our primary concern. By entering these trials, exhibitors acknowledge they are familiar with the rules and regulations of this sport and that their dogs are familiar with and physically able to perform all course elements.

**AWARDS:** Awards are offered for placements, high in class, and new titles.

**CONTEST:** There will be a competition for the best Luau theme decorated easyup/tent and best costume. More details will be provided in your final confirmation.

**REFUNDS & CANCELLATION POLICY:** After the closing date, entry fees will not be refunded if a person or dog is absent, disqualified, excused, or barred from competition by the action of the trial committee.

Every attempt will be made to hold this event as scheduled. The club will refund all monies less what is needed to pay for unrecoverable costs if the event cannot open or be completed because of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the event committee.

Abuse of any kind toward volunteers, dogs, rats, judges, competitors, grounds, or the trial committee will not be tolerated and will result in immediate dismissal from the event with no refund.

Withdrawals after the closing date due to injury of the dog will receive a 75% refund of paid entry fees. Request for a refund must be accompanied by a dated note from a veterinarian and must be emailed or mailed to the Trial Secretary before the close of the trial.

**SMOKING:** Smoking is not allowed except in your vehicle, and 100' or more of any building or porta john.

**FOOD:** We will be having a Luau themed potluck on both days. Our Hospitality Coordinator will reach out to you before the event.

**ON-SITE CAMPING:** On-site camping is allowed for this event; however, you must contact the Trial Secretary to make prior arrangements. Camping is \$10 per night. There is plenty of space. There are no showers.

**OFF-SITE ACCOMMODATIONS:** There are numerous dog-friendly hotels and campgrounds within 15 miles of 542 Valleycrest Dr., Dayton, OH 45404. We recommend the Comfort Inn or Red Roof Inn located in Huber Heights, Or Drury Inn located in Dayton.
