SPECIAL NOTICES

Transfers will be approved in accord with Chapter 1, Section 16a of the Obedience Regulations, provided that a written request is submitted to the Trial Secretary at least 30 min. prior to the start of the Trial, and that the limit has not been reached in the requested class.

This Obedience trial will use small to tall jump height order. This Rally trial will use small to tall jump height order Please include dog's jump height on your entry. If jump height is not provided, height will be assigned based on breed of dog and best estimate of height.

Catalogs will **not** be available for sale at the Trial. You may pre-order a catalog for \$6.00 by including payment with the entry fee.

Qualifying scores are required for all awards.

The club reserves the right to substitute a prize of equal or greater value. All awards must be claimed the day of the show – None will be mailed. Unclaimed prizes become the property of Gem City Agility Club.

Crates may be left inside the facility overnight in designated areas; dog may not be left overnight. No X-pens.

No smoking is allowed in the building. No alcoholic beverages are allowed on show grounds or in parking areas.

Entries fees will not be refunded in the event that a dog is absent, disqualified, excused by veterinarian or judge, or barred from competition by action of the Trial Committee. No entry fee will be refunded if the show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency, an act of public enemy, strikes, or any other cause beyond the control of Gem City Agility Club.

Exhibitors should follow their veterinarian's recommendations to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

Refunds for females in season (after closing date) will be given upon satisfactory verification of bitch being in season less \$5.00 processing fee; satisfactory evidence may include vet's statement; notice to be given per AKC rules Chapter 1, Section 14.

Gem City does not agree to arbitrate claims as set forth on the official AKC entry form for these events.

No meals will be served to exhibitors on site. There are fast food restaurants in the area or you may bring your own lunch.

Gem City will follow State of Ohio guidelines for Montgomery County and City of Dayton for COVID-19.

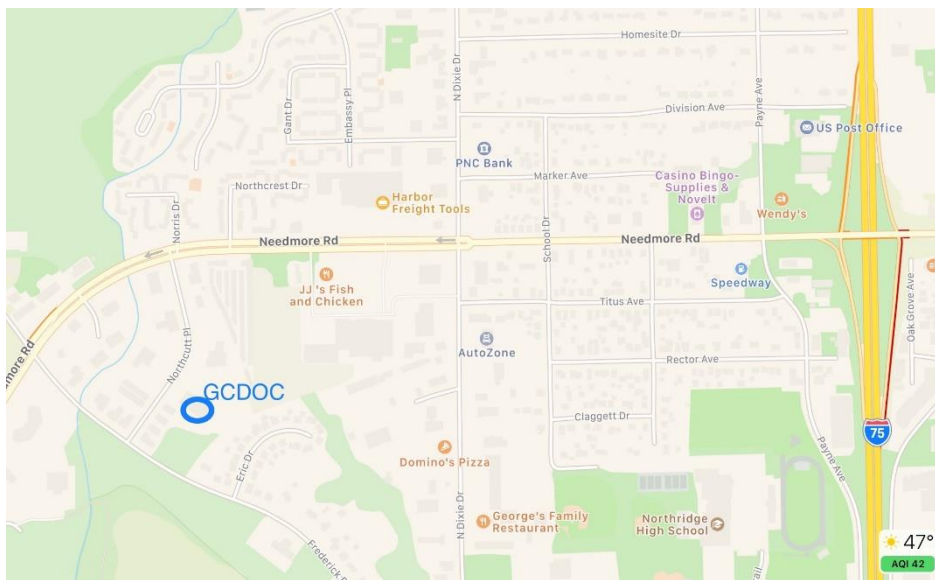
