She will work with the dog outside of the building until she feels he can be allowed inside around the other dogs. When he comes inside he will be wearing a basket muzzle. This will occur on Wednesday nights, which is also the same night Michelle is in classes. The board wanted to make sure that Michelle felt safe with the dog in the building. After a discussion, Michelle agreed to the plan

as long as layers of protection for her dog are in place. Deb must make sure that her dog (Braxton) is in his crate and the other dog must wear a muzzle in the building.

# Board Meeting - BUILDING MAINTENANCE REPORT: October 13, 2024

- 1) Emergency call to plumber on first day of trial.
- 2) The "hole" in the back wall of the turf room was repaired/covered.
- 3) The abandoned Flyball wood structure needs to be disposed of.
- 4) Annual year end maintenance for the tractor and zero turn mowers with repair is due.
  - a) Repair of the PTO on tractor ~ \$450
  - b) Annual Service on tractor plus transportation SWAG to be\$1000
  - c) Service on the Zero turn mower estimated to be \$581
  - d) Total \$2031. This might be high or low.
- 5) We have about 1/3 of the perimeter at the land which needs to be cleared of trees and brush. This needs to be a priority in order to maintain the property.
- 6) Repair of missing fence at the Land TBD. See other discussion for details.

### FENCE ISSUE AT THE LAND

This was discovered just this past Monday, October 7<sup>th</sup> by Suzie Freeze and Rosa Delks who were checking the fence for coyote holes.

- About 25 feet of the 6' fence was cut and stolen sometime in the last 3-4 months. The posts and rail are still there. No quote yet on replacement but the trees/brush/trash need to be removed first.
- This is in the far back of the property to the north of the back "gate".
- This is beyond where the Earth Dog trials are held.
- The entire east end and most of the north end of the property line are badly overgrown about 50 feet out from the fence. You really have to want to go back there to see it.
- That entire area also has become a dumping ground for the local community (?) or maybe only a few bad actors. Lots of large pick-up sized tires, buckets. Almost all are well overgrown.
- Any report to the city will result in the inspector coming out to review it.
- If the city comes out and we do not have actual proof of dumping, WE are responsible to have it removed, probably within the month. Or face a fine ourselves.
- In order to remove it the brush/trees need to be removed out at least 10 feet.
- Estimate of 30-40 tires which we will have to pay to be disposed of.
